## **HOUSING AND DEVELOPMENT ACT (CHAPTER 129)**

### **HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) (NO. 11) ORDER 2009**

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 11) Order 2009 and shall come into operation on 8th October 2009.

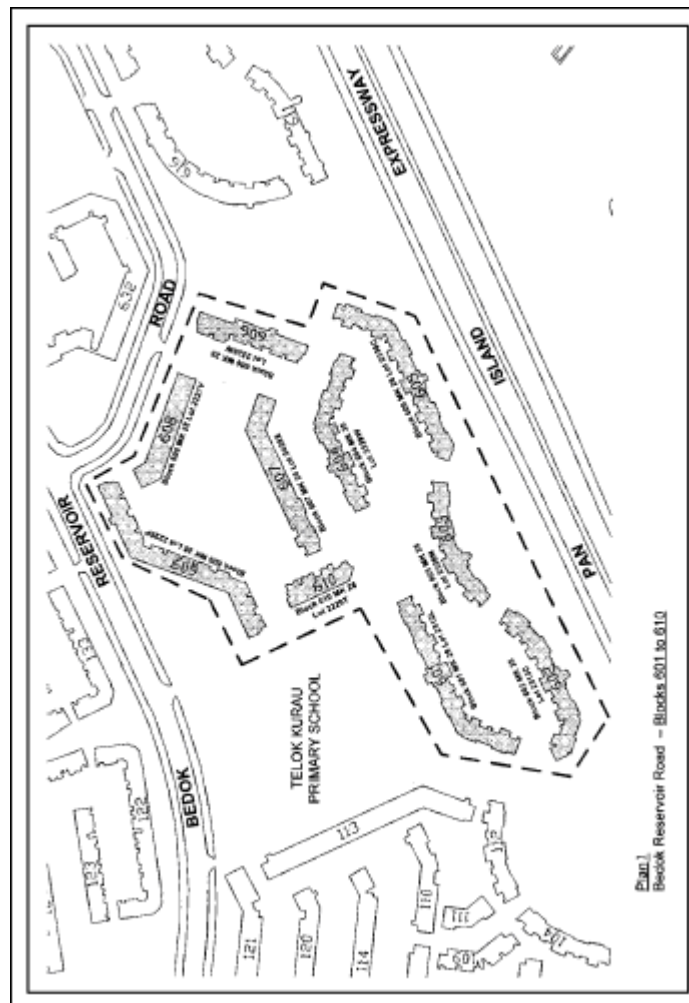
#### **Declaration of precincts for lift upgrading works**

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

## THE SCHEDULE

1. All that part of the housing estate of the Board at Bedok Reservoir Road comprised in Lot numbers 2312L, 2313C, 2328M, 2329W, 2330C, 2226W, 2428X, 2227V, 2228P and 2229T in Mukim 28 and on which Apartment Blocks 601, 602, 603, 604, 605, 606, 607, 608, 609 and 610 are erected, and which is more particularly delineated in Plan 1.

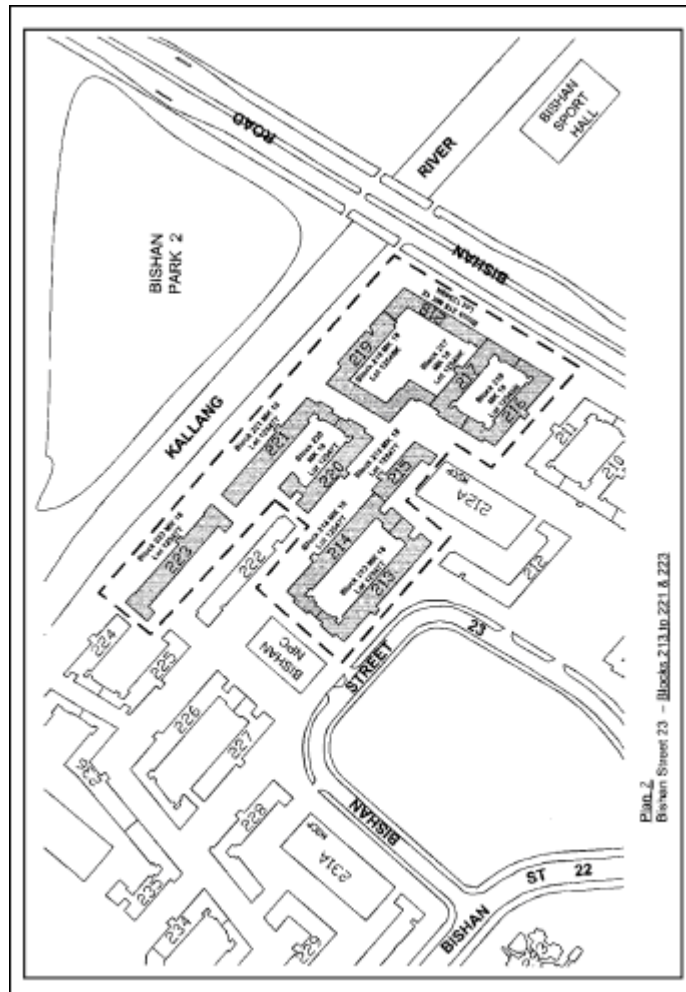
PLAN 1

All that part of the housing estate of the Board at Bishan Street 23 comprised in Lot number 12547T in Mukim 18 and on which Apartment Blocks 213, 214, 215, 220, 221 and 223 are erected, and in Lot number 12549K in Mukim 18 and on which Apartment Blocks 216, 217, 218 and 219 are erected, and which is more particularly delineated in Plan 2.

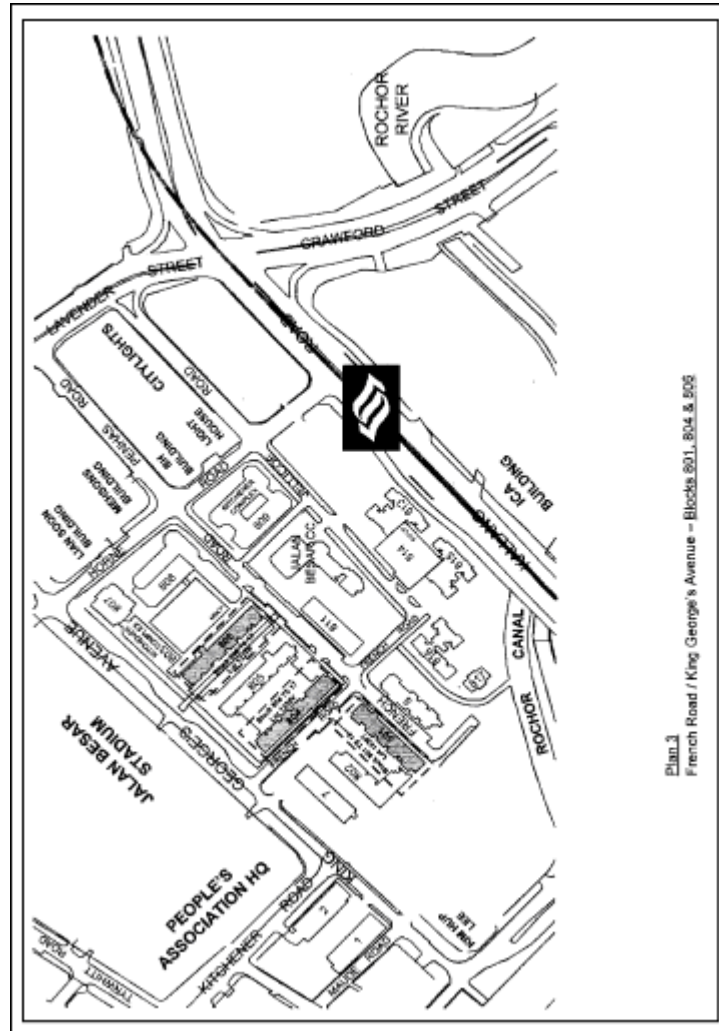
PLAN 2
