## **ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT) RULES 2008**

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

### **Citation and commencement**

**1.** These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment) Rules 2008 and shall come into operation on 4th February 2008.

### **Amendment of First Schedule**

**2.** The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2007 (G.N. No. S 738/2007) is amended —

- (a) by deleting all the items under the heading “CHARGES” in Part 5 and substituting the following items:

#### **CHARGES**

Amount of road-user charge payable on any day from Monday to Friday, not being a public holiday.

- (c) by deleting all the items under the headings “CHARGES ON WEEKDAYS” and “CHARGES ON SATURDAYS” in Part 12 and substituting the following items:

#### CHARGES ON WEEKDAYS

Amount of road-user charge payable on any day from Monday to Friday, not being a public holiday, except where such day falls on the eve of the New Year, Lunar New Year, Hari Raya Puasa, Deepavali and Christmas, the restricted hours shall cease at 1 p.m.
