**ENDANGERED SPECIES (IMPORT AND EXPORT) ACT (AMENDMENT OF
SCHEDULE) NOTIFICATION 2007**

In exercise of the powers conferred by section 28 of the Endangered Species (Import and Export) Act 2006, the Minister for National Development hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Endangered Species (Import and Export) Act (Amendment of Schedule) Notification 2007 and shall come into operation on 4th March 2007.

Amendment of Schedule

2. The Appendices in the Schedule to the Endangered Species (Import and Export) Act 2006 are amended —

- (a) by deleting the item “*Epixerus ebii* (Ghana)” in Appendix III under the sub-heading “Sciuridae Ground squirrels, tree squirrels” of the taxon “RODENTIA” (page 30);

- (b) by deleting the sub-heading “Anomaluridae African flying squirrels” and all the items thereunder of the taxon “RODENTIA” (page 31);
- (c) by deleting the sub-heading “Hystriidae Crested porcupine” and the item thereunder of the taxon “RODENTIA” (page 31);
- (d) by deleting the country “Ghana” in the item relating to “*Mellivora capensis*” in Appendix III under the sub-heading “Mellivorinae Honey badger” of the taxon “CARNIVORA” (page 35);
- (e) by deleting the sub-heading “Tragulidae Mouse-deer” and the item thereunder of the taxon “ARTIODACTYLA” (page 42);
- (f) by deleting the following items in Appendix III under the sub-heading “Bovidae Antelopes, cattle, duikers, gazelles, goats, sheep, etc.” of the taxon “ARTIODACTYLA” (pages 47 and 48):
 - (i) *Damaliscus lunatus* (Ghana);
 - (ii) *Tragelaphus eurycerus* (Ghana); and
 - (iii) *Tragelaphus spekii* (Ghana);
- (g) by deleting the sub-heading “Ardeidae Egrets, herons” and all the items thereunder of the taxon “CICONIIFORMES” (page 50);
- (h) by deleting all the items in Appendix III under the sub-heading “Ciconiidae Storks” of the taxon “CICONIIFORMES” (page 50);
- (i) by deleting all the items in Appendix III under the sub-heading “Threskiornithidae Ibises, spoonbills” of the taxon “CICONIIFORMES” (pages 50 and 51);
- (j) by deleting the following items in Appendix III under the sub-heading “Anatidae Ducks, geese, swans, etc.” of the taxon “ANSERIFORMES” (pages 51 and 52):
 - (i) *Alopochen aegyptiacus* (Ghana);
 - (ii) *Anas acuta* (Ghana);
 - (iii) *Anas capensis* (Ghana);
 - (iv) *Anas clypeata* (Ghana);
 - (v) *Anas crecca* (Ghana);
