### **HOUSING AND DEVELOPMENT (PRECINCTS FOR LIFT UPGRADING WORKS) (NO. 2) ORDER 2007**

In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 2) Order 2007 and shall come into operation on 17th January 2007.

#### **Declaration of precincts for lift upgrading works**

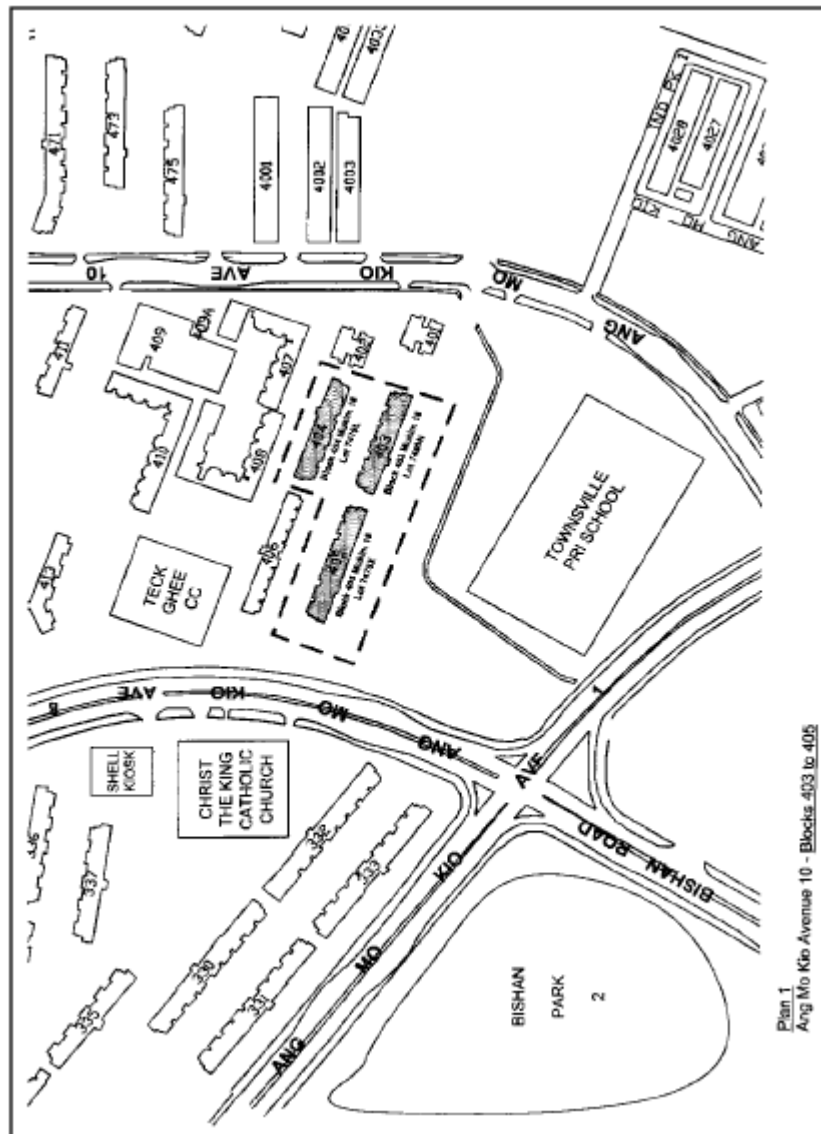
2. The parts of the housing estate of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

## THE SCHEDULE

1. All that part of the housing estate of the Board at Ang Mo Kio Avenue 10 comprised in Lot numbers 7480N, 7479L and 7478X in Mukim 18 and on which Apartment Blocks 403, 404 and 405 are erected, and which is more particularly delineated in Plan 1.

#### ANG MO KIO AVENUE 10

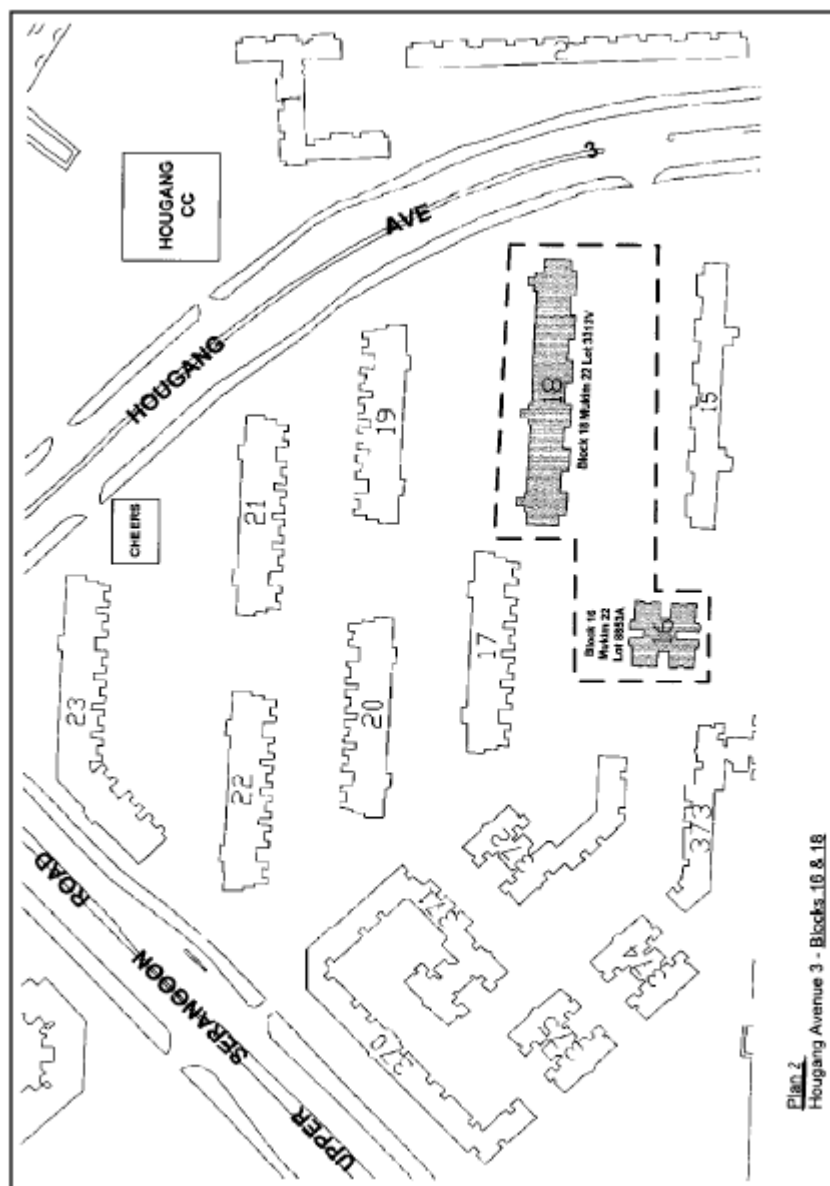

more particularly delineated in Plan 2.

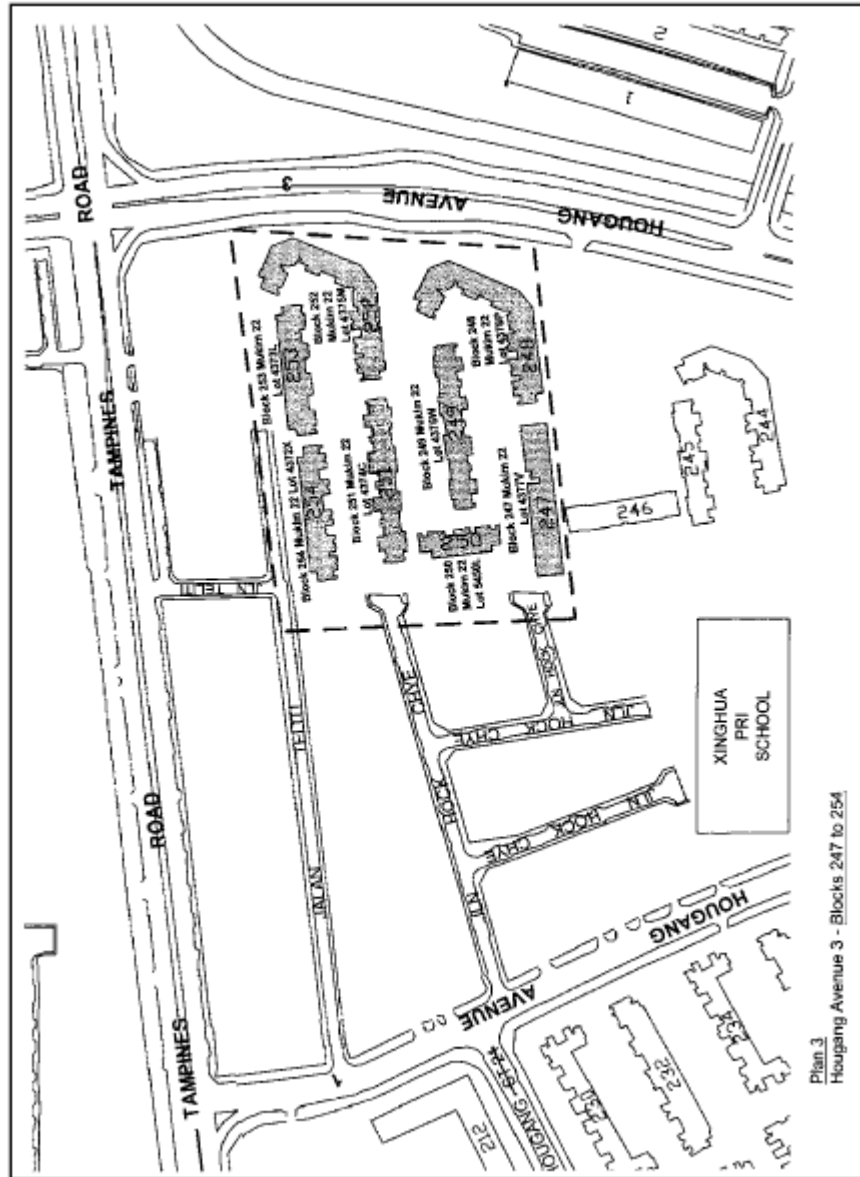
## PLAN 2

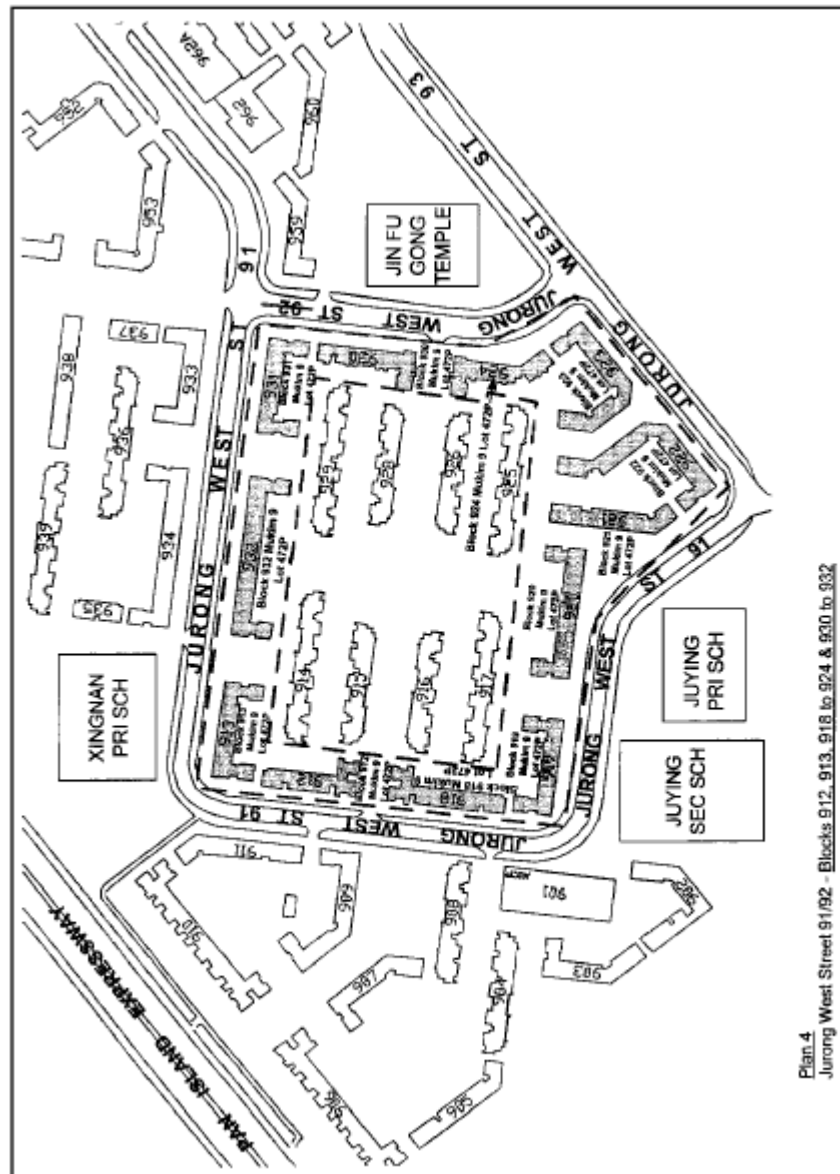
## HOUGANG AVENUE 3
