Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) Order 2007 and shall come into operation on 4th January 2007.

Declaration of precincts for lift upgrading works


2. The parts of the housing estate of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.




