# ROAD TRAFFIC ACT (CHAPTER 276)

# ROAD TRAFFIC (MOTOR VEHICLES, REGISTRATION AND LICENSING) (AMENDMENT NO. 4) RULES 2007

In exercise of the powers conferred by sections 34 and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

#### Citation and commencement

1. These Rules may be cited as the Road Traffic (Motor Vehicles, Registration and

Licensing) (Amendment No. 4) Rules 2007 and shall come into operation on 1st September 2007.

### Amendment of rule 36

- **2.** Rule 36 of the Road Traffic (Motor Vehicles, Registration and Licensing) Rules (R 5) (referred to in these Rules as the principal Rules) is amended
  - (a) by deleting the word "or" at the end of paragraph (4)(b);
  - (b) by deleting sub-paragraph (c) of paragraph (4) and substituting the following sub-paragraphs:
    - "(c) the Ninth Schedule, if the licence commences on any date between 1st September 2002 and 31st August 2007 (both dates inclusive); or
    - (d) the Eleventh Schedule, if the licence commences on or after 1st September 2007.";
  - (c) by deleting the word "or" at the end of paragraph (8)(b); and
  - (d) by deleting sub-paragraph (c) of paragraph (8) and substituting the following sub-paragraphs:
    - "(c) one-thirtieth of the appropriate fee in the Ninth Schedule, if the licence commences on any date between 1st September 2002 and 31st August 2007 (both dates inclusive); or
    - (d) computed in accordance with the following formula:

where Y is the number of days in the month; and

A is the appropriate fee in the Eleventh Schedule, if the licence commences on or after 1st September 2007.".

#### Amendment of rule 36A

- **3.** Rule 36A of the principal Rules is amended
  - (a) by deleting the word "or" at the end of paragraph (a); and
  - (b) by deleting paragraph (b) and substituting the following paragraphs:

- "(b) the Ninth Schedule, if the licence commences on any date between 1st September 2002 and 31st August 2007 (both dates inclusive); or
  - (c) the Eleventh Schedule, if the licence commences on or after 1st September 2007.".

### Amendment of rule 36B

- **4.** Rule 36B of the principal Rules is amended
  - (a) by deleting the word "or" at the end of paragraph (a); and
  - (b) by deleting paragraph (b) and substituting the following paragraphs:
    - "(b) the Ninth Schedule, if the licence commences on any date between 1st September 2002 and 31st August 2007 (both dates inclusive); or
      - (c) the Eleventh Schedule, if the licence commences on or after 1st September 2007.".

#### Amendment of rule 38B

- **5.** Rule 38B (4) of the principal Rules is amended
  - (a) by deleting the word "or" at the end of sub-paragraph (a)(i); and
  - (b) by deleting sub-paragraph (ii) of sub-paragraph (a) and substituting the following sub-paragraphs:
    - "(ii) the Ninth Schedule, if the licence commences on any date between 1st September 2002 and 31st August 2007 (both dates inclusive); or
    - (iii) the Eleventh Schedule, if the licence commences on or after 1st September 2007,".

#### **Amendment of Ninth Schedule**

**6.** The Ninth Schedule to the principal Rules is amended by deleting the Schedule heading and substituting the following Schedule heading:

"FEES PAYABLE FOR VEHICLE LICENCES COMMENCING ON ANY DATE BETWEEN 1ST SEPTEMBER 2002 AND 31ST AUGUST 2007

# (BOTH DATES INCLUSIVE) OTHER THAN VEHICLE LICENCES TO WHICHRULE 36C APPLIES".

## FEES PAYABLE FOR VEHICLE LICENCES COMMENCING ON OR AFTER 1ST SEPTEMBER 2007 OTHER THAN VEHICLE LICENCES TO WHICH RULE 36C APPLIES

Description of vehicle	Fee payable half-yearly
1. Motor cars having cylinder capacity (referred to in this Schedule by the letter "E")—	
(a) not exceeding 600 cubic centimetres	\$200 x 0.92
(b) exceeding 600 cubic centimetres but not exceeding 1,000 cubic centimetres	[\$200 + 2 <u>0.25 (E</u> <u>-600)</u> ] x 0.92
(c) exceeding 1,000 cubic centimetres but not exceeding 1,600 cubic centimetres	[\$250 + 2 0.75 (E = 1,000)] x 0.92
(d) exceeding 1,600 cubic centimetres but not exceeding 3,000 cubic centimetres	[\$475 + 2 1.5 (E – 1,600)] x 0.92
(e) exceeding 3,000 cubic centimetres	[\$1,525 2 + 2.0 (E = 3,000)]

2. Electric cars having a power rating (referred to in this Schedule by the letters "PR")—

(a) not exceeding 7.5 kW

\$200 x 0.92

(b) exceeding 7.5 kW but not exceeding 27.5 kW

[\$200 + 2 \$5 (PR -7.5)] x 0.92

(c) exceeding 27.5 kW but not exceeding 57.5 kW

[\$250 + 2 \$15 (PR -27.5)] x 0.92

(d) exceeding 57.5 kW but not exceeding 127.5 kW

[\$475 + 2 \$30 (PR - 57.5)] x 0.92

(e) exceeding 127.5 kW

[\$1,525 2 + \$40 (PR -127.5)] x 0.92

3. Hybrid cars

The higher of the appropriate fee payable under item 1 or 2 based on the hybrid car's cylinder capacity or power rating.

- 4. Motor cycles and scooters having cylinder capacity —
- (a) not exceeding 200 cubic centimetres

(b) exceeding 200 cubic centimetres but not exceeding 1,000 cubic centimetres
