ENVIRONMENTAL PUBLIC HEALTH ACT (CHAPTER 95)

ENVIRONMENTAL PUBLIC HEALTH (PUBLIC CLEANSING) (AMENDMENT) REGULATIONS 2006

In exercise of the powers conferred by section 111 of the Environmental Public Health Act, the National Environment Agency, with the approval of the Minister for the Environment and Water Resources, hereby makes the following Regulations:

Citation and commencement

1.—(1) These Regulations may be cited as the Environmental Public Health (Public Cleansing) (Amendment) Regulations 2006.

(2) Regulations 2 (a) and 3 shall come into operation on 1st April 2006.

(3) Regulations 2 (b) and 4 shall come into operation on 1st May 2006.

(4) Regulations 2 (c) and 5 shall come into operation on 1st June 2006.

(5) Regulations 2 (d) and 6 shall come into operation on 1st July 2006.

(6) Regulations 2 (e) and 7 shall come into operation on 1st August 2006.

(7) Regulations 2 (f) and 8 shall come into operation on 1st September 2006.

Amendment of Second Schedule

2. The Second Schedule to the Environmental Public Health (Public Cleansing) Regulations (Rg 3) (referred to in these Regulations as the principal Regulations) is amended —

(a) by deleting paragraph 3 and substituting the following paragraph:

“3. Fees for the collection and removal of refuse from premises which are located in the area specified in the Fifth Schedule and which have been designated by the Director-General under section 8(2)(b) of the Act as premises whose occupiers shall use the service provided by the public waste collector licensee, Colex Holdings Ltd.:

Per month

(1) Domestic premises provided with —

(a) direct refuse collection \$19.95 per premises

(b) indirect refuse collection \$5.96 per premises.

(2) Non-domestic premises where daily quantity of refuse collected and removed —

(a) does not exceed 120 litres \$30.45 per premises

(b) exceeds 120 litres but does not exceed 240 litres \$85.05 per premises

(c) exceeds 240 litres but does not exceed 360 litres \$105 per premises

(d) exceeds 360 litres but does not exceed 660 litres \$317.10 per premises

(e) exceeds 660 litres but does not exceed 1,100 litres	\$486.68 per premises
(f) exceeds 1,100 litres	a combination of fees from subparagraphs (a) to (e) according to the combination of the least number of receptacles required to contain the daily refuse output and where more than one such combination of receptacles is possible, the combination of receptacles resulting in the lowest possible combined fee shall be applied.
(3) Hawker stalls, including stalls in public markets and markets managed by Statutory Boards, and those operating on temporary permits	\$30.45 per stall.”;

(b) by deleting paragraph 4 and substituting the following paragraph:

“4. Fees for the collection and removal of refuse from premises which are located in the area specified in the Sixth Schedule and which have been designated by the Director-General under section 8(2)(b) of the Act as premises whose occupiers shall use the service provided by the public waste collector licensee, SembWaste Pte Ltd.:

(1) Domestic premises provided with —	
(a) direct refuse collection	\$18.25 per premises
(b) indirect refuse collection	\$4.60 per premises.
(2) Non-domestic premises where daily quantity of refuse collected and removed —	
(a) does not exceed 120 litres	\$23.10 per premises
(b) exceeds 120 litres but does not exceed 240 litres	\$99.75 per premises
(c) exceeds 240 litres but does not exceed 360 litres	\$144.90 per premises
(d) exceeds 360 litres but does	\$304.50 per premises

not exceed 660 litres

(e) exceeds 660 litres but does not exceed 1,100 litres \$472.50 per premises

(f) exceeds 1,100 litres a combination of fees from subparagraphs (a) to (e) according to the combination of the least number of receptacles required to contain the daily refuse output and where more than one such combination of receptacles is possible, the combination of receptacles resulting in the lowest possible combined fee shall be applied.

(3) Hawker stalls, including stalls in public markets and markets managed by Statutory Boards, and those operating on temporary permits \$23.10 per stall.”;

(c) by deleting paragraph 5 and substituting the following paragraph:

“5. Fees for the collection and removal of refuse from premises which are located in the area specified in the Seventh Schedule and which have been designated by the Director-General under section 8(2)(b) of the Act as premises whose occupiers shall use the service provided by the public waste collector licensee, SembWaste Pte Ltd.:

Per month

(1) Domestic premises provided with —

(a) direct refuse collection \$17.85 per premises

(b) indirect refuse collection \$4.23 per premises.

(2) Non-domestic premises where daily quantity of refuse collected and removed —

(a) does not exceed 120 litres \$27.30 per premises

(b) exceeds 120 litres but does not exceed 240 litres \$81.90 per premises

(c) exceeds 240 litres but does not exceed 360 litres \$144.90 per premises

(d) exceeds 360 litres but does not exceed 660 litres	\$273 per premises
(e) exceeds 660 litres but does not exceed 1,100 litres	\$420 per premises
(f) exceeds 1,100 litres	a combination of fees from subparagraphs (a) to (e) according to the combination of the least number of receptacles required to contain the daily refuse output and where more than one such combination of receptacles is possible, the combination of receptacles resulting in the lowest possible combined fee shall be applied.
(3) Hawker stalls, including stalls in public markets and markets managed by Statutory Boards, and those operating on temporary permits	\$27.30 per stall.”;

(d) by deleting paragraphs 6 and 7 and substituting the following paragraphs:

“6. Fees for the collection and removal of refuse from premises which are located in the area specified in the Eighth Schedule and which have been designated by the Director-General under section 8(2)(b) of the Act as premises whose occupiers shall use the service provided by the public waste collector licensee, SembWaste Pte Ltd.:

Per month

(1) Domestic premises provided with —	
(a) direct refuse collection	\$19.38 per premises
(b) indirect refuse collection	\$5.70 per premises.
(2) Non-domestic premises where daily quantity of refuse collected and removed —	
(a) does not exceed 120 litres	\$24.34 per premises
(b) exceeds 120 litres but does not exceed 240 litres	\$99.83 per premises
(c) exceeds 240 litres but does not exceed 360 litres	\$147.19 per premises
