Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) Order 2006 and shall come into operation on 5th January 2006.

Declaration of precincts for lift upgrading works


2. The parts of the housing estate of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

BUKIT BATOK EAST AVENUE 4







PLAN 3


JURONG WEST STREET 41
