ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2006

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2006 and shall come into operation on 26th June 2006.

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended (by deleting Part IA and substituting the following Part:
