## **TOWN COUNCILS ACT (CHAPTER 329A)**

### **TOWN COUNCIL OF ALJUNIED (CONSERVANCY AND SERVICE CHARGES) BY-LAWS 2006**

In exercise of the powers conferred by section 24(1) of the Town Councils Act, the Town Council for the Town of Aljunied hereby makes the following By-laws:

#### **Citation and commencement**

**1.** These By-laws may be cited as the Town Council of Aljunied (Conservancy and Service Charges) By-laws 2006 and shall come into operation on 1st January 2007.

#### **Conservancy and service charges**

**2.** Every owner or tenant of —

*(a)* every flat in any residential or commercial property; and

(b) every stall in any market or food centre,  
of the Board within the Town of Aljunied shall pay to the Town Council on the first day of each month the appropriate conservancy and service charges set out in the Schedule.

### Goods and services tax

3.—(1) The conservancy and service charges specified in items 1 to 6 of the Schedule are inclusive of the goods and services tax chargeable under the Goods and Service Tax Act (Cap. 117A) on the services in respect of which such conservancy and service charges are payable.

(2) The conservancy and service charges specified in items 7 to 13 of the Schedule are not inclusive of the goods and services tax chargeable under the Goods and Services Tax Act on the services in respect of which such conservancy and service charges are payable, and the owner or tenant shall bear and pay to the Town Council the goods and services tax charged on the supply of such services in addition to the appropriate conservancy and service charges.

### Revocation

4. The Town Council of Aljunied (Conservancy and Service Charges) By-laws 2002 (G.N. No. S 108/2002) are revoked.

7. Shop with living accommodation	\$1.55 per square metre of the area of the shop subject to a minimum of \$50 in addition to the following conservancy and service charges for the equivalent room type:	
(a) 1-room flat	\$18.50.
