# PRESIDENTIAL ELECTIONS ACT (CHAPTER 240A)

# PRESIDENTIAL ELECTIONS (FORMS AND FEES) (AMENDMENT) REGULATIONS 2005

In exercise of the powers conferred by section 81 of the Presidential Elections Act, the Prime Minister hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Presidential Elections (Forms and Fees) (Amendment) Regulations 2005 and shall come into operation on 17th June 2005.

## Deletion and substitution of regulation 3

2. Regulation 3 of the Presidential Elections (Forms and Fees) Regulations (Rg 1) (referred to in these Regulations as the principal Regulations) is deleted and the following regulation substituted therefor:

# "Nomination papers

**3.** For the purposes of section 9(3) of the Act, the nomination paper shall be in Form P3 in the Schedule.".

### **Deletion and substitution of regulation 12**

**3.** Regulation 12 of the principal Regulations is deleted and the following regulation substituted therefor:

# "Return of election expenses

- 12.—(1) For the purposes of section 56(1) and (2) of the Act, the return respecting election expenses and the statement by a principal election agent accompanying any such return shall be in Form P14 in the Schedule.
- (2) For the purposes of section 56(2) of the Act, the statement by a candidate accompanying any return respecting election expenses shall be in Form P15 in the Schedule."

#### **Amendment of Schedule**

- **4.** The Schedule to the principal Regulations is amended
  - (a) by deleting Forms P3, P4 and P5 and substituting the following Form:
