ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 8) RULES 2005

In exercise of the powers conferred by sections 34D and 140 of the Road Traffic Act, the Minister for Transport hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment No. 8) Rules 2005 and shall come into operation on 21st November 2005.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules (R 38) is amended

- a) (by deleting all the items under the heading “CHARGES” in Part IA;
- b) (by deleting all the items under the heading “CHARGES” in Part II and substituting the following items:
