# SMOKING (PROHIBITION IN CERTAIN PLACES) (AMENDMENT) NOTIFICATION 2005

In exercise of the powers conferred by section 3(1) of the Smoking (Prohibition in Certain Places) Act, the National Environment Agency, with the approval of the Minister for the Environment and Water Resources, hereby makes the following Notification:

## Citation and commencement

1. This Notification may be cited as the Smoking (Prohibition in Certain Places) (Amendment) Notification 2005 and shall come into operation on 1st October 2005.

## Amendment of paragraph 2

- **2.** Paragraph 2 of the Smoking (Prohibition in Certain Places) Notification (N 1) is amended
  - (a) by inserting, immediately after the definition of "cinema", the following definition:

- ""clinical laboratory" means any premises used or intended to be used for any type of examination of the human body or of any matter derived therefrom for the purpose of providing information for the diagnosis, prevention or treatment of any disease or for the assessment of the health of any person, or for ascertaining the cause of death or the result of any medical or surgical treatment given to any person;";
- (b) by inserting, immediately after the definition of "foodshop", the following definition:
  - ""healthcare establishment" means any premises used or intended to be used for the provision of any service, or for carrying out any practice or procedure, that is related to the diagnosis, treatment or care of any person suffering from any disease, injury or disability;"; and
- (c) by inserting, immediately after the definition of "public service vehicle", the following definition:
  - ""public swimming pool" means any swimming pool licensed under section 63 of the Environmental Public Health Act (Cap. 95) or any swimming pool owned by the Government;".

### **Deletion and substitution of First Schedule**

**3.** The First Schedule to the Smoking (Prohibition in Certain Places) Notification is deleted and the following Schedule substituted therefor:

### "FIRST SCHEDULE

Paragraph 3(a)

- 1. Any amusement centre.
- 2. Any air-conditioned foodshop.
- 3. Any air-conditioned hall, ballroom or function room (including any such premises located in a hotel) during such time when it is used for holding a meeting, conference, seminar, course or an exhibition or for the purpose of serving meals.
  - 4. Any cinema or theatre.
