## **ROAD TRAFFIC ACT (CHAPTER 276)**

### **ROAD TRAFFIC (PRESCRIBED OFFENCES AND PRESCRIBED NOTICES) (AMENDMENT) RULES 2004**

In exercise of the powers conferred by sections 132, 134 and 140 of the Road Traffic Act, the Minister for Home Affairs hereby makes the following Rules:

#### **Citation and commencement**

**1.** These Rules may be cited as the Road Traffic (Prescribed Offences and Prescribed Notices) (Amendment) Rules 2004 and shall come into operation on 5th April 2004.

#### **Amendment of Second Schedule**

**2.** The Second Schedule to the Road Traffic (Prescribed Offences and Prescribed Notices) Rules (R 28) is amended —

(a) by deleting Form A and substituting the following Form:
