CENTRAL PROVIDENT FUND ACT (AMENDMENT OF FIRST SCHEDULE) NOTIFICATION 2003

In exercise of the powers conferred by section 7(8) of the Central Provident Fund Act, Dr Ng Eng Hen, Minister of State, Ministry of Education, charged with the responsibility of the Minister for Manpower, hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Central Provident Fund Act (Amendment of First Schedule) Notification 2003 and shall come into operation on 1st October 2003.

Amendment of First Schedule

2. The First Schedule to the Central Provident Fund Act is amended —
