
Declaration of precincts for lift upgrading works

2. The parts of the housing estate of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works in the precincts.



1. All that part of the housing estate of the Board at Pasir Ris Street 12 comprised in Lot number 1773pt in Mukim 31 and on which Apartment Blocks 101, 102, 103, 104, 105, 106, 107 and 108 are erected, and which is more particularly delineated in Plan 1.



All that part of the housing estate of the Board at Pasir Ris Drive 6 comprised in Lot number 2072pt in Mukim 31 and on which Apartment Blocks 422, 423 and 425 are erected, and in Lot number 1710pt in Mukim 31 and on which Apartment Blocks 426 and 427 are erected, and in Lot number 2073pt in Mukim 31 and on which Apartment Blocks 428 and 429 are erected, and which is more particularly delineated in Plan 2.
