PARKING PLACES ACT (CHAPTER 214)

PARKING PLACES (HOUSING AND DEVELOPMENT BOARD) (AMENDMENT NO. 3) ORDER 2002

In exercise of the powers conferred by section 9 of the Parking Places Act, the Minister for Transport hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Parking Places (Housing and Development Board) (Amendment No. 3) Order 2002 and shall come into operation on 1st September 2002.

Amendment of paragraph 3

2. Paragraph 3 of the Parking Places (Housing and Development Board) Order 2000 (G.N. No. S 440/2000) (referred to in this Order as the principal Order) is amended —

(a) by deleting the words “Parts I, II and IV” in the 3rd line of sub-paragraph

- (2) and substituting the words “Parts I and IV”;
- (b) by deleting the words “\$75 per month” in the 4th line of sub-paragraph (2) and substituting the words “\$90 per month”; and
- (c) by deleting the words “\$55 per month” in the 4th line of sub-paragraph (3) and substituting the words “\$65 per month”.

Deletion and substitution of paragraph 4

3. Paragraph 4 of the principal Order is deleted and the following paragraph substituted therefor:

“Charges for whole day or monthly parking coupons

4. There shall be payable for the whole day or monthly parking coupons in the Forms set out in the first column the charges set out opposite thereto in the second column:

<i>First column</i>	<i>Second column</i>
(a) Form 3	\$16.50
(b) Form 4	\$10
(c) Form 7	\$300
(d) Form 8	\$460.”.

Deletion and substitution of Schedule

5. The Schedule to the principal Order is deleted and the following Schedule substituted therefor:

Paragraph 3

PART I

PARKING CHARGES:

(1) For a motor car or a motor vehicle the weight of which unladen does not exceed 1,500 kilograms —

- (a) Mondays to Saturdays:

- (i) \$1 per half hour or part thereof (between 7 a.m. and 5 p.m.).
 - (ii) 50 cents per half hour or part thereof (between 5 p.m. and 1 a.m. the following day).
 - (b) Sundays and Public Holidays:
 - (i) 50 cents per half hour or part thereof (between 7 a.m. and 1 a.m. the following day).
 - (c) \$2 per night (between 10.30 p.m. and 7 a.m. the following day).
 - (d) \$160 per month.
- (2) For a motor vehicle with fewer than 4 wheels and the weight of which unladen does not exceed 400 kilograms —
- (a) 65 cents per day (between 7 a.m. and 10.30 p.m.).
 - (b) 65 cents per night (between 10.30 p.m. and 7 a.m. the following day).
 - (c) \$17 per month.
- (3) For a motor-cycle or a motor-scooter occupying 2 motor-cycle parking lots and the weight of which unladen does not exceed 400 kilograms —
- (a) \$1.30 per day (between 7 a.m. and 10.30 p.m.).
 - (b) \$1.30 per night (between 10.30 p.m. and 7 a.m. the following day).
 - (c) \$34 per month.

PART II

PARKING CHARGES:

- (1) For a motor car or a motor vehicle the weight of which unladen does not exceed 1,500 kilograms —
- (a) Mondays to Saturdays:
 - (i) 50 cents per half hour or part thereof (between 7 a.m. and 6 p.m.).
 - (ii) \$1 per entry (between 6 p.m. and 1 a.m. the following day).
 - (b) Sundays and Public Holidays:
 - \$1 per entry (between 7 a.m. and 1 a.m. the following day).

- (c) \$2 per night (between 10.30 p.m. and 7 a.m. the following day).
 - (d) \$90 per month.
- (2) For a motor vehicle with fewer than 4 wheels and the weight of which unladen does not exceed 400 kilograms —
 - (a) 65 cents per day (between 7 a.m. and 10.30 p.m.).
 - (b) 65 cents per night (between 10.30 p.m. and 7 a.m. the following day).
 - (c) \$17 per month.
- (3) For a motor-cycle or a motor-scooter occupying 2 motor-cycle parking lots and the weight of which unladen does not exceed 400 kilograms —
 - (a) \$1.30 per day (between 7 a.m. and 10.30 p.m.).
 - (b) \$1.30 per night (between 10.30 p.m. and 7 a.m. the following day).
 - (c) \$34 per month.

PART III

PARKING CHARGES:

- (1) For a motor car or a motor vehicle the weight of which unladen does not exceed 1,500 kilograms —
 - (a) Mondays to Saturdays:
 - (i) \$1 per half hour or part thereof (between 7 a.m. and 5 p.m.).
 - (ii) 50 cents per half hour or part thereof (between 5 p.m. and 1 a.m. the following day).
 - (b) Sundays and Public Holidays:
 - (i) 50 cents per half hour or part thereof (between 7 a.m. and 1 a.m. the following day).
 - (c) \$2 per night (between 10.30 p.m. and 7 a.m. the following day).
 - (d) \$140 per month.
- (2) For a motor vehicle with fewer than 4 wheels and the weight of which unladen does not exceed 400 kilograms —
 - (a) 65 cents per day (between 7 a.m. and 10.30 p.m.).
 - (b) 65 cents per night (between 10.30 p.m. and 7 a.m. the following day).

(c) \$15 per month.

(3) For a motor vehicle (not being a motor car) the weight of which unladen exceeds 1,500 kilograms —

(a) Mondays to Saturdays:

(i) \$2 per half hour or part thereof (between 7 a.m. and 5 p.m.).

(ii) \$1 per half hour or part thereof (between 5 p.m. and 10.30 p.m.).

(b) Sundays and Public Holidays:

\$1 per half hour or part thereof (between 7 a.m. and 10.30 p.m.).

(c) \$185 per month.

(4) For a motor-cycle or a motor-scooter occupying 2 motor-cycle parking lots and the weight of which unladen does not exceed 400 kilograms —

(a) \$1.30 per day (between 7 a.m. and 10.30 p.m.).

(b) \$1.30 per night (between 10.30 p.m. and 7 a.m. the following day).

(c) \$30 per month.

PART IV

PARKING CHARGES:

(1) For a motor car or a motor vehicle the weight of which unladen does not exceed 1,500 kilograms —

(a) 50 cents per half hour or part thereof (between 7 a.m. and 1 a.m. the following day).

(b) \$2 per night (between 10.30 p.m. and 7 a.m. the following day).

(c) \$140 per month.

(2) For a motor vehicle with fewer than 4 wheels and the weight of which unladen does not exceed 400 kilograms —

(a) 65 cents per day (between 7 a.m. and 10.30 p.m.).

(b) 65 cents per night (between 10.30 p.m. and 7 a.m. the following day).

(c) \$17 per month.

(3) For a motor-cycle or a motor-scooter occupying 2 motor-cycle parking lots and the weight of which unladen does not exceed 400 kilograms —

(a) \$1.30 per day (between 7 a.m. and 10.30 p.m.).
