TOWN COUNCIL OF JALAN BESAR (CONSERVANCY AND SERVICE CHARGES) (AMENDMENT NO. 2) BY-LAWS 2002

In exercise of the powers conferred by section 24(1) of the Town Councils Act, the Town Council for the Town of Jalan Besar hereby makes the following By-laws:

Citation and commencement

1. These By-laws may be cited as the Town Council of Jalan Besar (Conservancy and Service Charges) (Amendment No. 2) By-laws 2002 and shall come into operation on 1st January 2003.

Deletion and substitution of by-law 3

2. By-law 3 of the Town Council of Jalan Besar (Conservancy and Service Charges) By-laws (By 71) is deleted and the following by-law substituted therefor:

"Goods and services tax

3. The conservancy and service charges specified in the Schedule are inclusive of the goods and services tax chargeable under the Goods and Services Tax Act (Cap. 117A) on the services in respect of which such conservancy and service charges are payable.".

Amendment of Schedule

- 3. The Schedule to the Town Council of Jalan Besar (Conservancy and Service Charges) By-laws is amended —
 - (a) by deleting the words "Items 1 to 5" immediately below the heading "Monthly conservancy and service charges" in the second column;
 - (b) by deleting items 6 to 13 and substituting the following items:
