### **GOVERNMENT CONTRACTS (AUTHORISATION) (AMENDMENT) NOTIFICATION 2001**

In exercise of the powers conferred by section 2 of the Government Contracts Act, the Minister for Finance hereby makes the following Notification:

#### **Citation and commencement**

1. This Notification may be cited as the Government Contracts (Authorisation) (Amendment) Notification 2001 and shall be deemed to have come into operation on 1st September 2001.
