ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT) RULES 1999

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Communications hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Road Traffic (Electronic Road Pricing System) (Amendment) Rules 1999 and shall come into operation on 1st April 1999.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 1998 (G.N. No. S 176/98) is amended —

- (a) by deleting all the items under the heading "CHARGES" in Part I and substituting the following items:

Amount of road user charge payable on any day from Monday to Friday, not being a public holiday.

Amount of road user charge payable on any day from Monday to Friday, not being a public holiday except where such day falls on the eve of the New Year, Lunar New Year, Hari Raya Puasa, Deepavali and Christmas, the restricted hours shall cease at 1.00 p.m.
