INTERPRETATION ACT (CHAPTER 1)

DELEGATION OF POWERS (MINISTRY OF FINANCE) (AMENDMENT NO. 2) NOTIFICATION 1998

In exercise of the powers conferred by section 36 of the Interpretation Act, the Minister for Finance, with the approval of the President, hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Delegation of Powers (Ministry of Finance) (Amendment No. 2) Notification 1998 and shall be deemed to have come into operation on 1st November 1998.

Amendment of Schedule

2. The Schedule to the Delegation of Powers (Ministry of Finance) Notification 1998 (G.N. No. S 66/98) is amended —

- (a) by deleting the words “Permanent Secretary, Budget Division” under the heading “Ministries and Organs of State” in item 2 in Part I, item 5 in Part III and item 3 in Part IV and substituting in each case the words

“Permanent Secretaries”;

- (b) by deleting the words “Deputy Secretary, Budget Division” under the heading “Ministries and Organs of State” in item 4 in Part I, item 15 in Part II, item 7 in Part III and item 16 in Part IV, and substituting in each case the words “Deputy Secretaries”;
- (c) by deleting the headings “(G) Ministry of Finance — Budget Division” and “(H) Ministry of Finance — Revenue Division” in Part II and all the items relating thereto and substituting the following:
