### **ADMINISTRATION OF MUSLIM LAW ACT (CHAPTER 3)**

### **MUSLIM MARRIAGE AND DIVORCE (AMENDMENT) RULES 1998**

In exercise of the powers conferred by section 145 of the Administration of Muslim Law Act, the President of Singapore hereby makes the following Rules:

#### **Citation and commencement**

**1.** These Rules may be cited as the Muslim Marriage and Divorce (Amendment) Rules 1998 and shall come into operation on 15th April 1998.

#### **Amendment of rule 32**

**2.** Rule 32 of the Muslim Marriage and Divorce Rules (R 1) (referred to in these Rules as the principal Rules) is amended —

(a) by deleting paragraph (1) and substituting the following paragraph:

“(1) The following fees shall be payable to the Kadis or Naib Kadis:

| (f) | for preparing a certified copy of the notes of evidence of any proceedings before a Kadi or Naib Kadi (per page)                                       | \$25. |

”; and

- (b) by deleting “\$18” in the fifth line of paragraph (3) and substituting “\$22”.

### **Amendment of rule 33**

3. Rule 33 of the principal Rules is amended —

- (a) by deleting “\$15” in paragraph (1)(a) and substituting “\$17”; and  
(b) by deleting “\$8” in paragraph (1)(b) and substituting “\$12”.

### **Deletion and substitution of rule 34**

4. Rule 34 of the principal Rules is deleted and the following rule substituted therefor:
