CONSTITUTION OF THE REPUBLIC OF SINGAPORE

PUBLIC SERVICE (PERSONNEL BOARDS) (AMENDMENT NO. 3) ORDER 1998

In exercise of the powers conferred by Article 110D (1), (2) and (4) of the Constitution of the Republic of Singapore, the President hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Public Service (Personnel Boards) (Amendment No. 3) Order 1998 and shall come into operation on 1st January 1999.

Amendment of paragraph 2

2. Paragraph 2(1) of the Public Service (Personnel Boards) Order (O 3) is amended by deleting sub-paragraphs (a) and (j) in the definition of “General Services”.

Amendment of Schedule

3. The Schedule to the Public Service (Personnel Boards) Order is amended —

(a) by deleting paragraphs (a) and (b) in the second column of item 7 and substituting the following paragraph:

“Public officers in any of the General Services other than the Environmental Health Officer Service, Health Overseer Service, Technical Support Service and Technical Service holding posts in the Ministry of the Environment”;

- (b) by deleting the paragraph in the second column of item 8 and substituting the following paragraph:

“Public officers in any of the General Services other than the Customs Service holding posts in the Ministry of Finance.”;

- (c) by deleting sub-paragraph (ii) of paragraph (a) in the second column of item 11;
- (d) by deleting item 12;
- (e) by deleting paragraph (b) in the second column of item 18 and substituting the following paragraph:

“Public officers in any of the General Services other than the following Services, holding posts in the Ministry of National Development:

- (i) Technical Support Service;
- (ii) Bird Shooting Service;
- (iii) Dog Shooting Service;
- (iv) Caretaking Service;
- (v) Laboratory Attendants Service;
- (vi) Launch Engine Operation Service;
- (vii) Launch Operation Service;
- (viii) Mechanic/Tractor Driver Service;
- (ix) PCA Constable Service;
- (x) Telephone Operating Service;
- (xi) Veterinary Attendants Service;
- (xii) Primary Production (Workers) Service; and
- (xiii) Driving Service.”; and

- (f) by inserting, immediately after item 24, the following items:

“25.	Health Officer Service Personnel Board, Ministry of the Environment.	Public Officers in the Environmental Health Officer Service, wherever posted and Health Overseer Service holding posts
