## **CONSTITUTION OF THE REPUBLIC OF SINGAPORE**

### **PUBLIC SERVICE (PERSONNEL BOARDS) (AMENDMENT) ORDER 1998**

In exercise of the powers conferred by Article 110D(1), (2) and (4) of the Constitution of the Republic of Singapore, the President hereby makes the following Order:

#### **Citation and commencement**

1.—(1) This Order may be cited as the Public Service (Personnel Boards) (Amendment) Order 1998.

(2) Paragraphs 2(*a*) and (*e*), 3, 4(*b*) and 5 of this Order shall be deemed to have come into operation on 1st April 1998.

(3) Paragraphs 2(*b*), 7, 8 and 9 of this Order shall be deemed to have come into operation on 1st April 1997.

(4) Paragraphs 2(*c*) and 4(*a*) of this Order shall be deemed to have come into operation on 1st September 1995.

(5) Paragraphs 2(*d*) and 6 of this Order shall be deemed to have come into operation on 1st July 1996.

### **Amendment of paragraph 2**

2. The definition of “General Services” in paragraph 2(1) of the Public Service (Personnel Boards) Order (O 3) (referred to in this Order as the principal Order) is amended —

(*a*) by deleting paragraph (*e*) and substituting the following paragraphs:

“(*e*) the Singapore Immigration & Registration Junior Service;

(*f*) the Singapore Immigration & Registration Senior Service;”;

(*b*) by deleting paragraphs (*f*) and (*p*);

(*c*) by deleting paragraph (*g*);

(*d*) by deleting paragraph (*k*); and

(*e*) by deleting paragraph (*m*).

### **Amendment of item 13 in Schedule**

3. Item 13 in the Schedule to the principal Order is amended by deleting the words “Immigration (Subordinate) Service” in paragraph (*a*) in the second column and substituting the words “Singapore Immigration & Registration Junior Service or Singapore Immigration & Registration Senior Service”.
