# PARKING PLACES (HOUSING AND DEVELOPMENT BOARD) (AMENDMENT NO. 2) ORDER 1996

In exercise of the powers conferred by sections 3 and 9 of the Parking Places Act, the Minister for Communications hereby makes the following Order:




