PARKING PLACES (HOUSING AND DEVELOPMENT BOARD) (AMENDMENT) ORDER 1996

In exercise of the powers conferred by sections 3 and 9 of the Parking Places Act, the Minister for Communications hereby makes the following Order:

1. This Order may be cited as the Parking Places (Housing and Development Board) (Amendment) Order 1996 and shall come into operation on 1st February 1996.
