(CHAPTER 303)**

**SINGAPORE POLYTECHNIC (STUDENTS' UNION) REGULATIONS 1996**

In exercise of the powers conferred by section 23(1) of the Singapore Polytechnic Act, the Board of Governors of the Singapore Polytechnic, with the approval of the Minister for Education, hereby makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Singapore Polytechnic (Students' Union) Regulations 1996 and shall come into operation on 21st June 1996.

**Definitions**

2. In these Regulations, unless the context otherwise requires —

“Chairman” means the Chairman of the Council;

“constituent body” means a constituent body of the Union;

“Council” means the Council of the Union;

“Executive Committee” means the Executive Committee of the Union;
