- (b) the Environmental Public Health (Burning of Joss Sticks and Candles) Regulations (Rg 1);
- (c) the Environmental Public Health (Public Cleansing) Regulations (Rg 3);  
or
- (d) the Environmental Public Health (Food Hygiene) Regulations (Rg 16).

**IF THE COMPOSITION IS NOT PAID**
