Citation and commencement

1. This Order may be cited as the Road Traffic (Fixed Penalty) (Extension) Order (Northern Ireland) 1988 and shall come into operation on 17th October 1988.

Specified offences

2.—(1) The offences under the Articles of the Order listed in column 2 of the Schedule are, subject to the exceptions and limitations, if any, set out in that column, specified for the purposes of Article 198(2) of the Order.

(2) In relation to any Article in column 2 of the Schedule the entry in column 3 broadly describes offences under that Article.
