REGULATIONS, DATED 27TH SEPTEMBER 1973, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER SECTION 68 OF THE FOOD AND DRUGS ACT (NORTHERN IRELAND) 1958.

The Ministry of Health and Social Services, on behalf of the Secretary of State and in exercise of the powers conferred upon it by section 68 of the Food and Drugs Act (Northern Ireland) 1958(a), having consulted with such organisations as appear to it to be representative of interests substantially affected by these regulations, hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Food and Drugs (Miscellaneous Amendments) Regulations (Northern Ireland) 1973, and shall come into operation on 1st October 1973.

Amendment of regulations

2. The regulations mentioned in columns 1 and 2 of the Schedule shall have effect subject to the modifications and repeals specified in column 3.
