**Local Government (Modifications and Repeals of Education etc. Legislation)
Order (Northern Ireland) 1973**

Made 4th September 1973

Coming into operation 1st October 1973

*To be laid before the Parliament of the United Kingdom
under paragraph 4(5)(b) of the Schedule to the Northern
Ireland (Temporary Provisions) Act 1972.*

The Ministry of Education, on behalf of the Secretary of State and in exercise of the powers conferred on it by section 134 of the Local Government Act (Northern Ireland) 1972(a) and of every other power enabling it in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Local Government (Modifications and Repeals of Education etc. Legislation) Order (Northern Ireland) 1973 and shall come into operation on 1st October 1973.

2. The transferred provisions mentioned in columns 1 to 3 of the Schedule shall have effect subject to the modifications and repeals specified in column 4.

3. All assets either held by the council of a county or to which such a council was entitled immediately before 1st October 1973 solely in connection with a museum or art gallery established under the Public Libraries Act (Northern Ireland) 1924(b) and every liability attaching to such a council immediately before that date solely in connection with such a museum or art gallery, shall on that date be transferred to the district council of the district in which the museum or art gallery is situated; and accordingly as from that date by virtue of this Order and without any further conveyance, deed or transfer, assignment, notice or other instrument

(a) the said assets shall vest in the district council, and

(b) the said liabilities shall become liabilities of the district council.
