(1) On the authority of a warrant issued by the President, there may be expended from the Consolidated Fund, such monies,</li> <li>5 not exceeding in the aggregate eighty-six billion, eight hundred and seven million, eight hundred and ninety-four thousand, seven hundred and twenty-seven kwacha, as may be required for the services of the Republic during the financial year ending on 31st December, 2019.</li> </ul>	Appropriation
10 (2) The monies referred to in subsection (1) shall be appropriated to the services of the Republic specified in the second column of both the First Schedule and the Second Schedule, in amounts not exceeding the amounts indicated in the third column of both the First Schedule and the Second Schedule.	
15 (3) On the written authority of the Secretary to the Treasury, the amounts shown under the subheads in the First Schedule and under the programmes in the Second Schedule, may be varied, except that the amounts appropriated to each subhead in the First Schedule and the amounts appropriated to each programme in the 20 Second Schedule shall not be altered by the variation.
