This White Paper on Integrated Track and Trace for Multimodal Transportation showcases important milestones that contribute to the digitalization of multimodal transportation.

The timing of the publication is critical as international trade is going through a transition stemming from uncertainties related to the COVID-19 pandemic. Despite the pandemic and according to the United Nations Global Survey on Digital and Sustainable Trade Facilitation, UNECE member States reached a 76% average implementation rate of the Trade Facilitation Agreement of the World Trade Organization (WTO-TFA) in 2021. Building on this impressive rate of implementation, the White Paper assists in areas where there is still room for improvement on digital trade facilitation. Trade facilitation and digitalization are closely linked, as both aim at more efficient and rapid transportation processes.

Trade facilitation is a journey and a constantly moving target. This paper is an important contribution to this journey, keeping track of the key indicators for monitoring trade facilitation and guiding us to the creation of the data models and further standards necessary for supporting digitized track and trace for any single or multimodal transportation scenario.
