## Global Environment & Sustainability Law Fellowship

The Global Environment & Sustainability Law Fellowship aims to strengthen the environmental capacity of lawyers worldwide. The Fellowship provides the opportunity for environmental lawyers in developing countries to earn an Environmental & Energy Masters of Law Degree (LL.M.) at Georgetown. The Environmental & Energy Law LL.M. Degree is part of Georgetown Law's expansion of its environmental, energy, natural resources, land use, and water law curriculum and programming. Following their time at Georgetown, Fellows will train at United Nations Environment Programme (UNEP) offices as interns, then return to their home government to apply their enhanced expertise.

In its inaugural application cycle, the Law Center received approximately one hundred applications from around the globe. Finalists were selected based on their achievements, experience as environmental lawyers working in the public sector, and their passion for sharing this enrichment with their colleagues at home. The 2017 Law Fellows are Jeanie Namugga from Uganda and Andrea Jacobs from Antigua and Barbuda.

### 2017-2018 Fellows

Jeanie Namugga will focus her studies on the link between land use issues and the emerging oil and gas exploration market in Uganda. Before winning this Fellowship, Ms. Namugga worked in the Land and **Environmental Law Division** of the High Court of Uganda, writing draft judicial opinions. She has also been involved with multiple organizations focused on environmental, land use, and public justice issues including: the Ugandan Chapter of the International Federation of Women Lawyers; Avocats Sans Frontiers: the Coalition for the International Criminal Court; the Uganda Land Alliance; and the East African Regional Symposium on Public Interest Environmental Litigation.

Andrea Jacobs will focus her studies on development and climate change adaptation in the Caribbean. Further, she will explore interests in clean energy technology, electric and autonomous vehicles, and robotics. Ms. Jacobs' current work focuses on energy, environment, and development planning laws. She was the Chairman of the Development Control Authority Tribunal, where she heard matters on appeal relating to building permissions and breaches of the building code. She also represented Antiqua and Barbuda at the United Nations Framework Convention for Climate Change and was the coordinator for the Preambular and Compliance section of the Paris Agreement on behalf of the Alliance of Small Island States.

**\$250,000** would cover five years of nontuition related expenses for the entire Fellowship program. (\$25,000 for each of the Fellows, at two fellows per year.)

**\$50,000** would cover the living stipend of each Fellow for one year.

**\$16,000** would cover rent and utilities for the Fellows during one semester of law school.

**\$5,000** would allow each Fellow to return home once during their Fellowship (flying economy class) over the holiday break when the campus is closed.

**\$4,000** would provide new laptops and cover books for each incoming Fellow for the entire year.

**\$1,500** would provide Metro cards and commuter bikes to help the Fellows commute to and from their classes and internships for the entire year.

**\$1,000** covers the cost of a trip to the United Nations Headquarters in New York City for each Fellow.

**\$500** provides diploma frames, graduation caps and gowns for the Fellows.
