Sir, Madame,

I am writing on behalf of "**i d m**" - the International Dental Manufacturers' Association requesting membership of the UNEP Mercury Partnership. **i d m** is a global organization of regional dental associations which together represent the interests of more than 4 000 small and medium sized manufacturers. Our members include manufacturers of dental restorative materials such as mercury containing amalgam and amalgam separators for use on the waste outlets of dental surgeries. **i d m** members can contribute to the UNEP-GMP goals in two ways:

1. Retain amalgam as a proven and affordable restorative material.
Encourage research to develop an alternative to amalgam as a dental restorative material which will protect human health and over time, phase down the release of amalgam into the environment.
2. Supply a range of equipment compliant with *ISO 11143* Amalgam Separators to capture the amalgam waste and thus prevent mercury release to waterways and landfill.
3. **i d m** will also be actively encouraging it's members to engage with their domestic waste management companies to ensure the captured amalgam waste is handled according to UNEP guidelines.
