Letter of support – UNEP Global Mercury Partnership

This letter of support is to acknowledge our desire to join the Global Mercury Partnership facilitated by the UN Environmental Program (UNEP) with thematic focus on the reduction of mercury production and supply and mercury use in the artisanal gold mining.

Kyrgyz Mining Association is a non-governmental, self-governing, independent organization unrelated to political parties and movements. The mission of Kyrgyz Mining Association is to provide a broad, legal and technical expert support to the development of the mining industry of the Kyrgyz Republic.

Kyrgyzstan is the only country in the world, still producing mercury on industrial scale for export. In view of the UN efforts aimed at reduction of world's production and use of mercury, our Association would like to draw attention of the international experts and officers to the problem of economic transitioning of the Khaidarkan Mercury Plant. The simple cessation of mercury production at the Khaidarkan Mercury Plant without replacing the economic activities with sustainable alternatives would deprive the livelihoods of the mining town and its community of 10 thousand people, thereby causing a negative social impact. Local environmental issues should be resolved in parallel to the employment problem. In our country there is also a problem of uncontrolled use of mercury in artisanal gold mining.

Kyrgyz Mining Association fully aware that the production of mercury is a global challenge and it requires the sustained joint efforts to be addressed properly.

We would like to express our commitment to work within the framework of the UNEP Global Mercury Partnership, sharing knowledge and experiences with other members to halt the use of mercury in artisanal gold mining, and to reduce mercury production and supply.
