The country's current environmental health situation reflects a deepening crisis due to the absence of a strong government, proper governance, a regulatory and legislative framework, and inspectorate and monitoring systems. The number of local industries is steadily growing. But they remain unregulated, even though they have the potential to pollute the environment. Such industries include leather-tanning factories, soap producing industries and they operate without any regular inspection or supervision The fumes of extensive domestic charcoal use and commercial charcoal burning affect the health of the Somali people. The 3-year Somali Energy Transformation (SET) project is being implemented in Somaliland, Puntland and South Central Somalia. The initiative consists of solar photovoltaic market development, solar powered irrigation and community electrification schemes, along with the promotion of efficient cooking stoves and other elements⁵.
