



Cross-border trade in services (Exports)





- Average exports of services from 2011-2013 increased compared to average from 2008-2010.
- For APEC as a whole, CAGR from 2008 to 2013 was 5.03%.

Sectoral trade in services – Exports (Average, 2011-2013)



- For some economies, top services include: financial, insurance and pension; and telecommunications, computer and information.




Outward FDI in tertiary sector (latest year)
