1015-1200: High-level Panel Discussion: The Role of Trade Facilitation in Regional Integration for Inclusive and Sustainable Growth

The high level panel will review the role of trade facilitation in on-going regional integration efforts in the context of the global economic environment and the emergence of global value chains (GVCs). Recent initiatives and innovations aimed at reducing trade costs and facilitating more inclusive participation of businesses in international trade will be discussed, including China's "One Belt, One Road" Policy and the emergence of cross-border e-commerce services. 1330-1500: Session 1: Overcoming high trade costs of Asia-Pacific developing economies: Prioritizing Trade Facilitation Measures

High trade costs, cumbersome trade procedures and lack of export diversification are the commonly identified factors which prevent many developing countries, especially the least developed countries (LDCs), landlocked developing countries (LLDCs) and Small Island Developing States (SIDS) from penetrating regional and global market. This session aims to analyze how developing countries in the region have been integrated into regional and global economy through enhanced trade facilitation. The trade costs, implementation of trade facilitation measures, and salient features of international trade of selected LLDCs, LDCs and SIDS will be discussed in this session.

# 1530-1700: Session 2: Enhancing regional connectivity through trade and transport corridor facilitation

Trade and transport corridors are often regarded as lifeline for connecting landlocked developing countries with regional and international market. Accordingly, every effort to reduce trade costs, simplify trade procedures and facilitate transit along the corridors enhances the possibility to deliver products from the landlocked countries to international and regional markets cheaply and timely. This session aims to review matters on simplifying trade procedures in key components of trade and transport corridor in the region such as gateway ports and land-border crossings. 1045-1200: Session 4: Developing regional cross-border e-commerce through paperless trade

Cross-border e-commerce has unprecedented potential to enable small traders to participate in international trade and therefore contribute to inclusiveness of international trade. Despite this, cross border e-commerce in developing countries is still at its beginning stage of development and international dimension of e-commerce is relatively modest<sup>1</sup>. Among many issues to be addressed, reducing or eliminating the requirement for mandated paper-based documents in cross-border trade would be essential to develop
