A brief introduction of MNSW

- We initiated in 2005, UN/CEFACT #33 translated & submitted to the government, established WGs and approved national program on SW in 2007
- Did feasibility study, organized donors mtg, developed MNSW implementation master plan with the support of UNESCAP & submitted to the government in 2010
- Based on this, approved a steering committee on SW & appointed as leading/implementation agencies by MCGA and MNCCI based on PPP principle
- After the election 2012, the new government reorganized a steering committee on MNSW by its decision No: 69 on Mar 2013 which is headed by the cabinet secretariat



The current status of MNSW

- But the cabinet hasn't still decided for funding, other stakeholders are willing to implement it, we understood
- Organizing training, study tour, meeting in Mongolia & abroad on TF including BPA, SEW...
- For 2014, organized National Capacity Building Workshop on Implementing MNSW on 13-14 of Mar & invited all related stakeholders from private & public sector
- I'd like to emphasize that ESCAP, ADB's always support on developing MNSW implementation master plan & technical assistance for arising awareness on trade facilitation, SW





- In Mongolia, main critical concept of the SW, political will, stakeholder engagement, interagency coordination, legal issues and capacity building are going, being better but FUNDING not decided...
- Law on border port approved in Dec 2013 and effects into force 1st of Apr 2014
- According to the law, the border authority/border administration office is responsible for implementing MNSW and regulate the activities of the agencies which works at the cross border for example: customs, inspection agencies etc
