Background:
***Regional Strategic Framework for Facilitation of
International Road Transport***

- Existence of non-physical barriers can significantly impede transit transport adversely affecting connectivity of countries to regional and global markets
- Developed by UNESCAP and based on a comprehensive study on non-physical barriers
- Adopted by the Ministerial Conference on Transport held at Bangkok in March 2012
- Identifies main challenges to international road transport and provides long term targets to provide coherence and process to achieve them
- Provides seven modalities to support facilitation of international road transport

***Background:
Regional Strategic Framework for Facilitation of
International Road Transport***

- **One of the modalities under RSF is building effective legal regime through:**
 - **Establishment of a regional network of legal experts on transport facilitation;**
 - **Accession to selected international; facilitation conventions;**
 - **Subregional agreements;**
 - **Bilateral agreements.**

Background:
***ESCAP Project on the Establishment of the Regional
Network of Legal and Technical Experts on Transport
Facilitation***

- **Financed by the Government of the Russian Federation**
- **Includes studies on:**
 - Comparisons of subregional facilitation agreements
 - Relationship between international facilitation conventions and subregional facilitation agreements
- **Meetings to launch the network and to share knowledge and outcomes of the studies**

- **Suggest solutions to legal conflicts where a country is party to two or more agreements**

- **Share experiences**
- **Promote international facilitation conventions and the formulation and implementation of subregional facilitation agreements;**
- **Assist in the development and improvement of bilateral agreements on international road transport**
