**OPENING STATEMENT**

Across the Asia-Pacific region, subregional intergovernmental organizations and programmes have been active in promoting physical and institutional connectivity within their respective subregions. Under the framework of subregional organizations and programmes, over 40 agreements related to transport facilitation have been signed to promote and facilitate cross-border transport by road and railway. They are at the different stages in the implementation. Many of the agreements are overlapped in geographical scopes.

With increasing demand for development of regional connectivity and intra-regional trade, effective implementation of the subregional agreements has become an important but challenging task for most regional member countries, as it requires involvement of multiple government authorities, amendments to domestic legislation, streamlining existing formalities and procedures, and restructuring functions of some agencies and authorities. Strong political support from member countries, as well as financial and technical support from international organizations and institutions is needed in order to successfully implement such agreements.

The main objective of this Seminar is to provide an opportunity for the subregional organizations and programmes as well as their participating countries to share information and experience on the formulation and implementation of main subregional agreements related to cross-border and transit transport facilitation in the region, to promote the implementation of the subregional agreements
