2.1 Scope of the NAMA and design Elements

Objective:

Seek the views on the building blocks of the proposed NAMA, which are its
physical boundaries, proposed objectives and its core elements.

- Is the proposed boundary (urban and peri-urban) too broad? Should it be made more detailed or narrow?
- What else could be added to the proposed objectives of the NAMA?
- What are your thoughts on the proposed measures under the NAMA?

2.2 The proposed NAMA in the policy context of Viet Nam

Objective:

 Discuss how the proposed NAMA fits into existing policies, strategies and programmes in Viet Nam, and how it can reinforce and go beyond them

- Does the proposed NAMA support existing policies, programs, strategies and targets in the waste and climate change sectors of Viet Nam?
- What are the policy gaps that the NAMA could bridge?
- Could the NAMA go beyond the targets and objectives set by the government? Or simply support them?

2.3 Financing Issues

Objective:

 Discuss what financing aspects related to the implementation of the NAMA, including barriers, financing mechanisms, and role of the private sector.

- What are the current/usual financing methods in the waste sector in Viet Nam?
- What are the main barriers to investment, both public and private?
- What is the role envisioned to the private sector in the waste sector, and how could it be supported by the proposed NAMA?
- Where could the boundary between unilateral and supported NAMA be set?
- What are the instruments and mechanisms that could be leveraged to finance actions within the umbrella of this NAMA? Low-interest loans? Grants?
- Are there any existing mechanisms in Viet Nam that could support GHG emission reductions in the waste sector?

2.4 Governance structure and roles & responsibilities of stakeholders

Objective:

 Discuss how the governance structure of the waste sector, as well as the roles and responsibilities of different actors could be clarified and streamlined with the proposed NAMA.

- What are the main gaps in the governance structure of the solid waste sector in Vietnam? Are the roles and responsibilities of each stakeholder well defined and integrated?
- What should be the involvement of the different levels of government in the implementation and monitoring of the NAMA?
- What could be the role of the informal sector in the proposed NAMA? And how could its role be reinforced with the NAMA?
- Which organizations should take part in the steering committee of the NAMA?

2.5 Technical Aspects of the Proposed Programme

Objective:

 Discuss technical aspects related to the baseline definition and the MRV systems that will need to be in place for designing and implementing the NAMA

Guiding questions:

- What are the main technical challenges with the implementation of the proposed measures in terms of collecting data, availability and measurement of GHG emission reductions?
- Do existing international recognized methodologies support the GHG reduction measures proposed, such as recycling?
