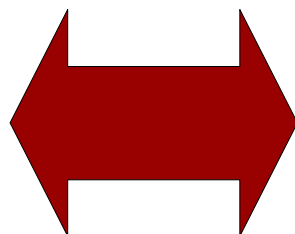

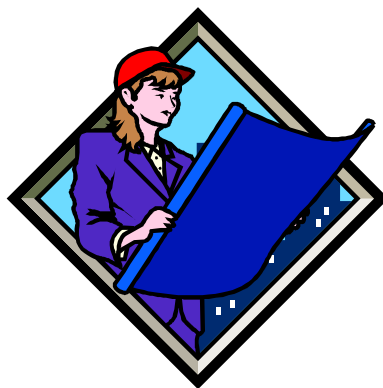

Regional Study on Regulatory Frameworks for LSPs

Main findings and recommendations

LSPs go largely “unnoticed” in national regulations

But due to complex services face a **labyrinth of regulation** and are exposed to **wider range of risk**.

Policy support

An integrated approach is required by control authorities to support the development of logistics service provision.

Logistics services providers need to be tracked by government and industry for **more informed policy making**.

Complex and customized services

Standard trading conditions can be developed for LSPs particularly to formalize industry best
