Law (Plant Protection Law)	<p>(Purpose of the Law) To ensure the stabilization and development of agricultural production by inspecting export plants, imported plants and domestic plants, by controlling injurious animals and plants, and by preventing the outbreak or spreading</p> <ul style="list-style-type: none"> •General Provisions •Import restriction and Import prohibition •Inspection of import plants •Disinfestations and disposal of plants •Inspection of export plants •Restriction of internal movement of plants •Emergency control •Pest forecasting •Domestic control by prefectural government ,etc.
Ministerial Ordinance (Enforcement Regulation of the Plant Protection Law)	<p>Detailed provisions to enforce the Plant Protection Law.</p> <ul style="list-style-type: none"> •Public hearing •List of entry points •Quarantine pests list •List of area/plant/pest combinations (subject to growing site inspection in exporting countries) (subject to import prohibition) •Procedures on import inspection application •Certification of phytosanitary import clearance •Procedures on export inspection application,etc.
Notification and Regulations	<p>To officially announce and enforce the regulations of plant protection and quarantine activities.</p> <p>[Import]</p> <ul style="list-style-type: none"> •Standards for import inspection (method of inspection and sample size) •Standards for disinfestations and disposal (methods of disinfestations and destruction) •Plants not subject to plant quarantine •Requirements for lifting import prohibition,etc. •Requirements for quarantine facilities (eg. fumigation chamber) <p>[Export]</p> <ul style="list-style-type: none"> •Standards for export inspection (method of inspection and sample size) •Standards for growing site inspection ,etc.
Instructions	<p>To provide instructions for officers who are engaged in plant protection and quarantine activities.</p> <ul style="list-style-type: none"> •Working instructions for seed and seedling quarantine •Working instructions for fresh fruit and vegetable quarantine •Detailed requirements on lifting import prohibition ,etc.
Manuals	<p>To provide manuals to adequately conduct plant protection and quarantine activities.</p> <ul style="list-style-type: none"> •Monitoring survey manuals •growing site inspection manuals ,etc.
