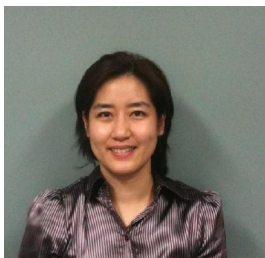

**Witada Anukoonwattaka** is serving as an economist for the Trade and Investment Division, ESCAP. She received a PhD in economics from the University of Melbourne in 2007. Witada joined ESCAP in 2011. She was previously a lecturer in the Faculty of Economics at Thammasat University, and was also the assistant director and research fellow at the APEC study centre (now renamed the International Cooperation Studies Centre) of Thammasat University. She has been a consultant to ESCAP and served with several government agencies. Her research areas of interest are on product fragmentation and multinationals, preferential and multilateral trade liberalization.



**Nilanjan Banik** is an Associate Professor at IFMR, Chennai. He holds degrees in Economics from Utah State University, USA; and Delhi School of Economics, Delhi. His areas of interest are strategic trade policies and time series econometrics. Nilanjan has teaching experiences with Utah State University, Indian Institute of Management, Madras School of Economics and Reserve Bank of India Staff College. He has project experiences with Laffer Associates, USA; RIS and ICRIER, New Delhi; ADBI, Tokyo; ADB, Manila; ARTNeT, Bangkok, etc. He has publications in many peer reviewed journals, and in edited volumes with publishers like Elsevier, Springer-Verlag, Routledge, etc.



**Sudip Ranjan Basu** is an economist with International Trade Division, UNCTAD. He has been a Visiting Lecturer at the Graduate Institute as well as a Visiting Research Scholar at the University of Pennsylvania and International Food Policy Research Institute. Prior to UNCTAD, he worked at the ILO, the World Bank, (Indian) NIPFP, and the University of Geneva. He has written on trade policy, development planning, emerging economies (China-India), WTO accession, applied econometric modelling and economic forecasting models. He has contributed to UN flagship reports, edited books, academic journals and coordinated multi-agency research program on Non-tariff Measures.



**Biplove Choudhary** works with the Inclusive Growth and Poverty Reduction Practice at the UNDP Regional Centre for Asia Pacific in Bangkok. A development economist with over 11 years of experience at the policy, research and grass-roots levels, he has been working with UNDP since 2007. Before joining the UNDP Regional Centre in Bangkok, he was posted at the Regional Centre in Colombo. Earlier, he headed CENTAD, the Trade and Development arm of Oxfam in South Asia and had been an advisor to civil society organizations, national governments and international agencies such as Commonwealth Secretariat-DFID, and various UN agencies. Biplove holds a Ph.D. in international trade and human development from the Jawaharlal Nehru University, New Delhi and is a former Fellow of the Cambridge Advanced Programme on Rethinking Development Economics. He has published on poverty and inclusive growth in academic journals, books and mainstream media.



**Kornkarun Cheewatrakoolpong** is a lecturer at Faculty of Economics, Chulalongkorn University. She is the author of "Towards a better understanding of the political economy of regional integration in the GMS: Stakeholder coordination and consultation for subregional trade facilitation in Thailand," sponsored by the ARTNeT program (2009). She also has several published papers, chapters of edited volumes, and journal articles. Her current work concentrates on trade facilitation, trade agreements, FDI and technological spillovers and trade diversification.



**Aekapol Chongvilaivan** is Fellow and Coordinator of the Regional Economic Studies Programme at the Institute of Southeast Asian Studies (ISEAS), Singapore. Prior to joining ISEAS, he was Research Fellow at Department of Economics, National University of Singapore. His research interests zero in on international trade & finance, labor economics and applied econometrics with emphasis on East Asian economies. His recent publications include papers in *Economic Inquiry*, *Southern Economic Journal*, *Applied Economics*, *World Economy* and *Journal of Institutional and Theoretical Economics*; in addition to authored books and book chapters.



**Alan V. Deardorff** is John W. Sweetland Professor of International Economics and Professor of Economics and Public Policy at the University of Michigan. He is currently serving as Associate Dean of the Gerald R. Ford School of Public Policy. He received his Ph.D. in economics from Cornell University in 1971 and has been on the faculty at the University of Michigan since 1970. He is co-author, with Robert M. Stern, of *The Michigan Model of World Production and Trade and Computational Analysis of Global Trading Arrangements*, and he has published numerous articles on aspects of international trade theory and policy, including theories of the patterns and effects of trade and, with



Professor Stern and with Drusilla K. Brown, on computable general equilibrium models of trade policy. He has served as a consultant to the United States Departments of Commerce, Labor, State, and Treasury and to international organizations including the Organisation for Economic Co-operation and Development (OECD) and the World Bank.

**Evan Due** is Senior Program Specialist responsible for economic and trade programs at the International Development Research Centre (IDRC) Regional Office for Southeast and East Asia in Singapore. Prior to joining IDRC in 2003, he served with the Government of Canada in various positions with the Canadian International Development Agency, including diplomatic assignments in Pakistan (including Afghanistan) and India, senior economist in the Policy Branch, and analyst in the Asia Branch. During this period, he also served as the lead member of Canada's delegation to the OECD Development Assistance Committee Working Party on Financial Aspects, and the DAC Network on Poverty Reduction. From 1987 to 1990, he worked as technical advisor in the Ministry of Policy and Planning, Government of Sri Lanka. Evan Due's interests include public policy, political economy and institutional economics, and poverty analysis. He recently co-authored the book *Fighting Poverty with Facts: Community Based Monitoring Systems* with Celia Reyes in 2009. He received his doctorate from the University of Sussex.



**Jane Drake-Brockman** is an international trade policy expert, with extensive trade negotiating experience, having held senior trade advisory positions in the Australian Department of Foreign Affairs and Trade, including Deputy Head of the Australian Mission to the European Union in Brussels. She has an honours degree in economics from Australian National University and 30 years of economic and trade policy experience in government, international governance (UNCTAD, Commonwealth Secretariat, OECD), business, academia and the parliament. She has provided expert advice over the last decade to a range of international clients on trade and environment policy issues, on which she has a well established record of academic publications. She holds a Visiting Fellowship at the Centre for Arab and Islamic Studies at Australian National University. She is also Executive Director of the Australian Services Roundtable, the peak business body for the Australian services sector, which she was instrumental in founding.



**Simon J. Evenett** is Professor of International Trade and Economic Development at the University of St. Gallen, Switzerland, and Co-Director of the CEPR Programme in International Trade and Regional Economics. Evenett coordinates the Global Trade Alert initiative. Evenett taught previously at Oxford and Rutgers University, and served twice as a World Bank official. He was a non-resident Senior Fellow of the Brookings Institution in Washington. He is Member of the High Level Group on Globalisation established by the French Trade Minister Christine LaGarde, Member of the Warwick Commission on the



Future of the Multilateral Trading System after Doha, and was Member of the Zedillo Committee on the Global Trade and Financial Architecture. In addition to his research into the determinants of international commercial flows, he is particularly interested in the relationships between international trade policy, national competition law and policy, and economic development. He obtained his Ph.D. in Economics from Yale University.

**Smitha Francis** is an economist with Economic Research Foundation (ERF), a research institute in Delhi, which also acts as the secretariat for International Development Economics Associates (IDEAs). IDEAs is a pluralist network of progressive economists across the world committed to developing and using alternative heterodox tools of economic analysis appropriate for meeting contemporary development challenges. Smitha Francis was a Visiting Fellow at the Chulalongkorn University Social Research Institute (CUSRI), Bangkok during 1998-2000. Prior to this, she has worked at the Research and Information System (RIS), New Delhi. While she has presented papers at national and international conferences and has published papers and contributed to edited volumes, most of her work is also available at [www.networkideas.org](http://www.networkideas.org). Her area of interest is development economics, with special interest in international trade and finance and the East and Southeast Asian economies.



**Hamid Mahmood** is currently working as a Senior Economist in the Planning Commission for the past 3 years. He specializes in macroeconomic modeling with specific reference to trade and taxation reforms. He is also a faculty member at Pakistan Institute of Trade & Development where he teaches International Trade Theory. His recent publications focus on areas such as: Pakistan's potential of trade in services, the effectiveness of human resource development for small and medium Enterprises (SME) in South Asia and the role of FDI and remittances in socio-economic development.



**Somprawin Manprasert** is currently an assistant professor at the Faculty of Economics, Chulalongkorn University, Thailand. He graduated from the University of Maryland at College Park in 2004 and was completing his doctoral dissertation in the area of interindustry macroeconomic model. During the past years, his research works relate to international trade and household consumption. His papers include, for example, *The Analysis of Thailand's Free Trade Agreements: An Area-Based Evaluation*, *ASEAN and China Free Trade Area: Implications for Thailand*, and *Life Cycle-Permanent Income Hypothesis and Liquidity Constraints in Thai Households: Evidence from Micro Data*. His current interests are business cycle and economic modeling.





**Mia Mikic** is an international trade economist in the Trade and Investment Division, ESCAP and the coordinator of ARTNeT. Previously, she was Professor at the University of Zagreb and Senior Lecturer at the University of Auckland. She is the author of *International Trade* (Macmillan, 1998), co-authored *Trade Statistics in Policymaking – A handbook of commonly used trade indices and indicators* (United Nations, 2009) and has contributed chapters to several edited volumes and reports and published a number of journal articles and other papers. Her current work focuses on PTA, APTIAD, services trade liberalization, non-tariff protection, Aft and evidence-based policymaking in trade.



**Manuel F. Montes** (“Butch”) is Chief, Policy Analysis and Development Branch at Financing for Development Office UNDESA. Prior to this, he was Regional Programme Coordinator, Asia Pacific Trade and Investment Initiative, UNDP Regional Centre in Colombo, Sri Lanka, where he assisted developing countries in the Asia Pacific in incorporating poverty reduction objectives in their trade policies. He previously served as: Programme Officer for International Economic Policy at the Ford Foundation in New York, 1999-2005; Senior Fellow and Coordinator for economics studies at the East-West Centre in Honolulu, 1989-1999; and Associate Professor of Economics at the University of The Philippines, 1981-1989. He has been a visiting scholar at the Institute for Developing Economies in Tokyo, United Nations University/World Institute for Development Economics Research (UNU/IWDER) in Helsinki, and the Institute for Southeast Asian Studies (ISEAS). His most recent publication is *Poverty and Well-Being in Asia during the Transition* (Palgrave-Macmillan, 2003). Butch holds a PhD in Economics from Stanford University.



**Kazuyuki Motohashi** is Professor, Department of Technology Management for Innovation (TMI), University of Tokyo and Faculty Fellow of Research Institute of Economy, Trade and Industry. Until this year, he had worked for Ministry of Economy, Trade and Industry of the Japanese Government, as well as Directorate for Science, Technology and Industry of OECD. He was awarded Master of Engineering from University of Tokyo, MBA from Cornell University and Ph.D. in business and commerce from Keio University.



**Biswajit Nag** is an Associate Professor of Economics at Indian Institute of Foreign Trade (IIFT), New Delhi. He did his specialization in International Trade & Business, Industrial Economics and Applied Econometrics. He has teaching experience in India, Tanzania and Germany. Dr. Nag has also worked in number of trade policy related projects sponsored by Govt. of India, UN, ADB and World Bank. His current research interest is, International Production Network, Global Value Chain, Trade in



Services, Trade and Macroeconomic issues, Regional Trade Agreements, etc. He is also a member of the Expert Group on Preferential Rules of Origin, Government of India. Dr. Nag has number of international publications. Currently, he is the Programme Director of IIFT's MBA (International Business) Programme.

**Purushottam Ojha** is the Secretary, Economic Affairs and Infrastructure Development Division in the Office of the Prime Minister and Council of Ministers, Government of Nepal since May 2011. Previously, he served as the Secretary in the Ministry of Commerce and Supplies for more than



four years (April 2007 to May 2011). He worked as the Project Director in Nepal Multimodal Transit and Trade Facilitation Project for four years from 1997 to 2001 and was responsible for development of Inland Clearance Depots (ICDs) and the trade facilitation. He was also responsible for introduction of multi-modal transport system. Mr. Ojha holds two Master Degrees: one in Public Administration with specialization on Development Administration and another in Anthropology from Tribhuvan University, Nepal. He has authored more than 50 articles in the field of trade, transit, regional trade agreements and economic cooperation, particularly focusing on the issues of least developed countries and published in various national and international journals.

**Rina Oktaviani** is currently Professor of International Trade at the Department of Economics, Bogor Agricultural University, Indonesia with more than 15 years of professional research, lecturing and consulting experience in the field of trade and economic development. She possesses sound expertise in in-depth quantitative analysis, particularly General Equilibrium Model on trade-related studies covering multilateral trade arrangements and sector impact assessments in South East Asia (ASEAN), East Asia, and Asia-Pacific and has produced several books, book chapters, journal article and working papers. Since 2011, she is involved in advisory team for Trade Research and Development Agency (TREDA) - Ministry of Trade and Fiscal Policy Office, Ministry of Finance, Indonesia.
