



FOREWORD

UN-HABITAT is mandated by the Nations General Assembly to promote socially and environmentally sustainable towns and cities with the goal of providing adequate shelter for all. Today, the housing situation in Malawi and many other countries, especially for the urban poor, is still far from adequate. To address this challenge, the Government of Malawi embarked on a review of the National Housing Policy and requested UN-HABITAT to contribute to this process. a team of Malawian and international experts has carried out the profiling research. The approach is based on a holistic view of housing and focuses on its five components: land; basic services; housing finance; building materials and construction technologies; and labour/employment. The Profile assesses how these components are governed by policy, institutional and legal frameworks. Through a thorough evaluation of the urban land and housing markets (supply and demand/ needs), the Profile discloses the factors that hinder markets from functioning properly, leading to the exclusion of certain social groups. Based on the research findings, recommendations have been derived to inform the housing policy reform process in Malawi and the design of programmes, including implementation arrangements, for enhancing the performance of the urban housing delivery system. The Profile is expected to serve as key tool for all actors in the housing sector in their joint efforts to generate affordable housing opportunities at scale.

UN-HABITAT also supports urban sector profiling in Malawi to help inform urban poverty reduction policies. This parallel initiative will provide an analysis of the wider urban context, thus complementing the Malawi Urban Housing Sector Profile. UN-HABITAT's particular focus on housing reflects the importance of this sector for the overall economy. A thriving housing sector contributes to economic growth through creation of employment opportunities in the building materials and construction sector, and other forward and backward linkages.

A MESSAGE FROM

Shelter is a basic requirement for all citizens. It is only those citizens who have adequate shelter that can contribute effectively to the country's development. In situations where people live in poor housing, they are likely to suffer from poor health and other indicators.
