FOREWORD

Over the past few decades, much progress has been made in the Western Pacific Region in reducing the burden of communicable diseases, including tuberculosis (TB), malaria and HIV/AIDS. TB prevalence has decreased more than half and TB deaths by over 73% since 1990. The HIV/AIDS burden has lowered as antiretroviral therapy coverage has increased in the Region. Nine out of 10 malaria-endemic countries achieved their Millennium Development Goal malaria targets. Millions of deaths and disabilities have been prevented through immunizations. This success against communicable diseases has accelerated progress towards universal health coverage (UHC) in countries.

While working to sustain and improve upon these achievements, countries in the Region face a long and evolving list of challenges. Noncommunicable disease rates continue to rise, accounting for nearly 80% of preventable deaths. The Region is an epicentre for outbreaks and health emergencies, with an average of 200 health security threats each year. Demand for high-quality health services continues to grow, as reductions in external funding for health take hold in many countries.

To meet these challenges, countries must look to sustainable financing mechanisms to strengthen health systems towards UHC. This whole-of-system approach is detailed in the *Regional Framework for Action on Transitioning to Integrated Financing of Priority Public Health Services in the Western Pacific*. The Framework provides guidance to help secure essential public health functions that can ensure the sustainability and resilience of health systems. The Framework spells out actions for countries to transition smoothly to sustainable financing for priority public health services. The guidance will assist countries facing external funding cuts that need to strengthen domestic or integrated financing. At the same time, the Framework addresses the needs of countries undergoing service delivery and budgeting reforms to advance UHC and Sustainable Development Goals (SDGs).

WHO developed the Framework at the request of Member States, based on their expe-
