Dear Ambassador,

I have the honour, under the mandate given to me by the Council of the Organisation, to invite the Republic of Korea to participate in the work of the Steel Committee as provided below.

The Steel Committee operates on the basis of the applicable provisions of the Convention on the Organisation for Economic Co-operation and Development² and Council Decision C(78)171(Final). The Republic of Korea is invited to become a participant in the work of the Steel Committee on an equal footing with OECD Member countries, by:

(i) agreeing to co-operate in the activities of the Steel Committee in fulfillment of its mandate, in particular, to keep the other participants informed and furnish the Committee with the information necessary for the accomplishment of its tasks, and to contribute appropriately to financing the activities of the Committee, and

(ii) accepting the multilateral guidelines set out in paragraph 6 of the Annex of Council Decision C(78)171(Final).

After 1993, the amount of the contribution of the Republic of Korea would be established in accordance with the rules of the Organisation, on the same basis as that of other participating countries. The initial contribution of the Republic of Korea would be 1.3% of the expenses of the Committee for that part of 1993 during which the Republic of Korea is a participant.
