**PROTOCOL TO EXTEND

The Government of the Republic of Latvia and the Government of the United States of America,

Acting pursuant to Article XIII of the Agreement between the Government of the Republic of Latvia and the Government of the United States of America Concerning Cooperation in the Area of the Prevention of Proliferation of Weapons of Mass Destruction of December 11, 2001, as amended (the “Agreement”),

Have agreed as follows:

**Article 1**

The term of the Agreement shall be extended for seven years, to May 5, 2017.

**Article 2**

This Protocol shall enter into force on the date of a note from the Ministry of Foreign Affairs of the Republic of Latvia to the Department of State of the United States of America confirming that the Government of the Republic of Latvia has completed all of its internal procedures required for entry into force of the Protocol.

IN WITNESS WHEREOF, the undersigned, being duly authorized by their respective Governments, have signed this Protocol.

DONE at Washington, in duplicate, this *4<sup>th</sup>* day of *May*, 2010, in the English and Latvian languages, both texts being equally authentic.
